1. Similarly, conditional offers with terms and conditions inconsistent with those contained in this document shall be rejected.
2. The tenderer shall deposit the sum of Rs.30,00,000/- (Rupees Thirty Lakhs Only) as "Performance Security Deposit" which will be returned without any interest, after receipt of goods/articles from the tenderer. The performance security deposit needs to be deposited with 24 hours of award of work.
3. The performance security shall be furnished in one of the following forms:

 - iii) Bank Guarantee


